- AWARDS:** We will award two team trophies and three individual medals (per weight class). Since we are awarding individual medals, wrestlers must wrestle the same weight class each dual. **To reduce confusion there will be no exception to this rule this year. Each team is allowed 14 entries, 1 at each weight class, no substitutions.**
- CONCESSION:** There will be a concession stand for wrestlers and spectators, and a hospitality room for coaches, officials and tournament workers and bus drivers.
- ENTRY FEE:** **Any deficit will be divided equally among the schools.**
